Outcome for Court

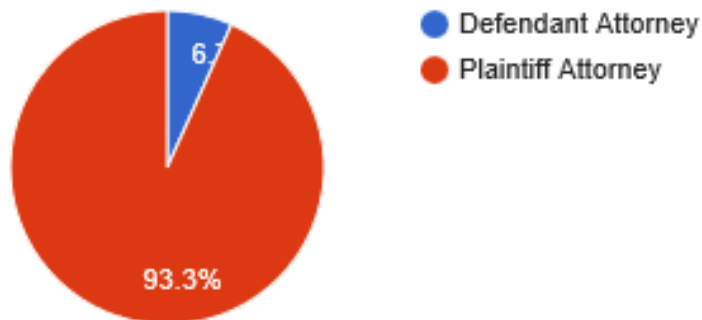


Outcome for Judge Hon. Not Available - Displaying Court Avera

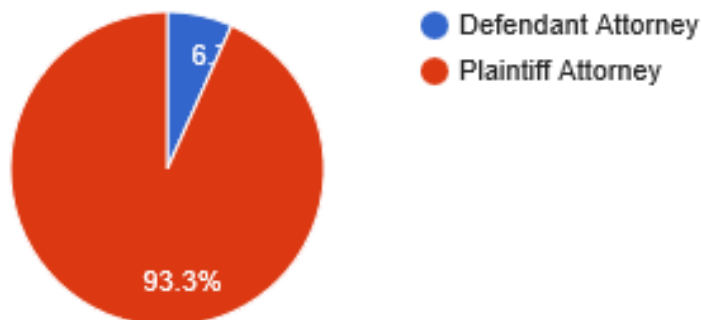

Outcome/Case Duration



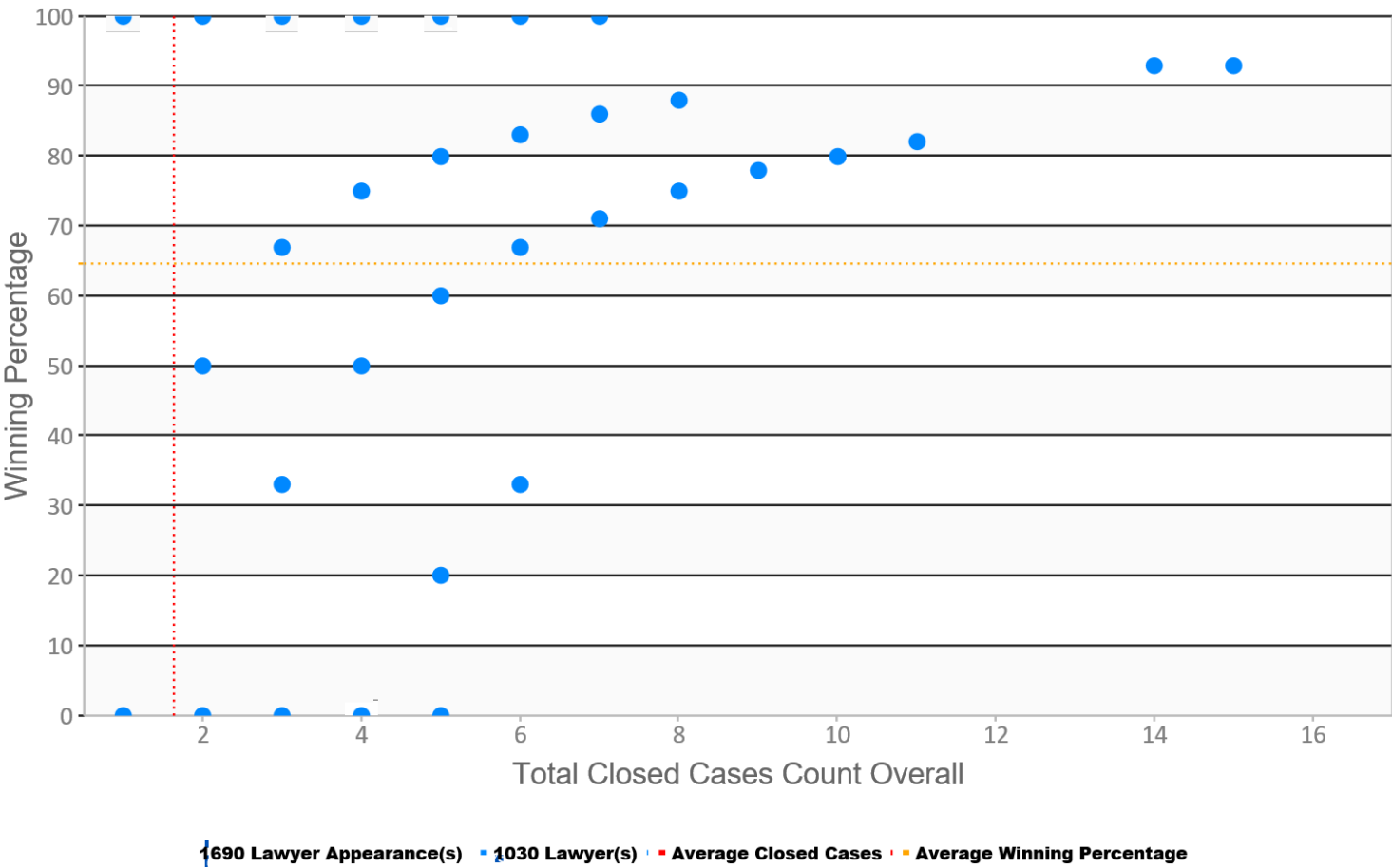
