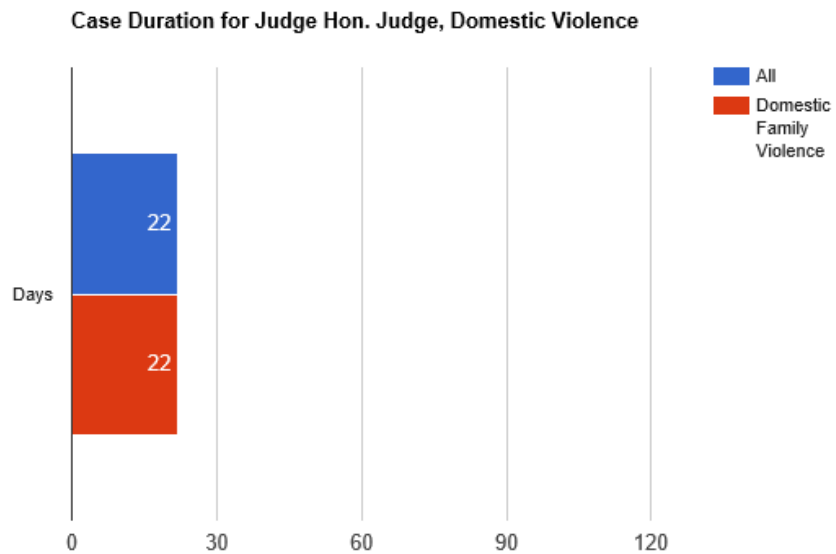
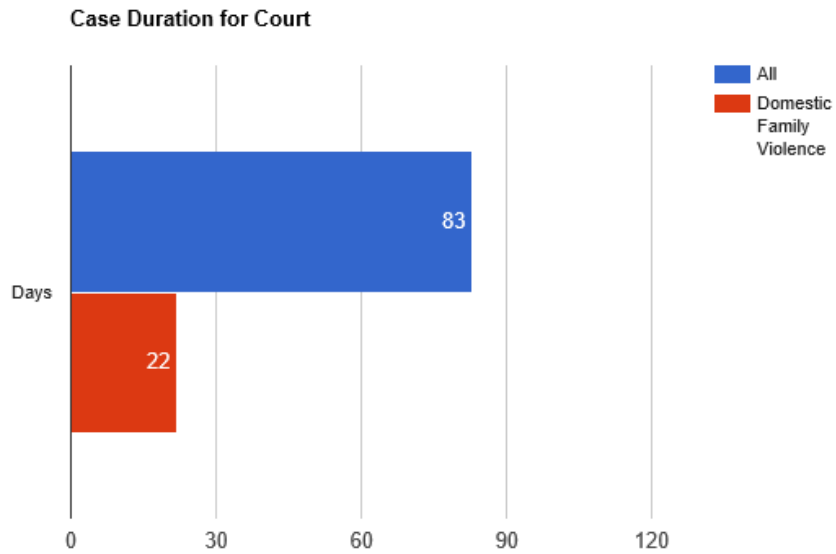
Case Count For Court



Case Count For Judge Hon. Judge, Domestic Violence

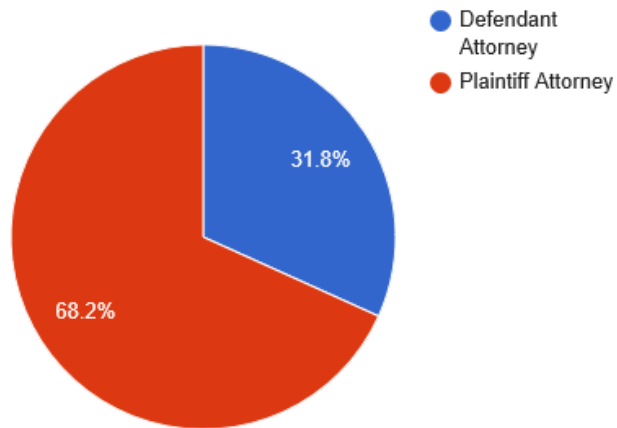

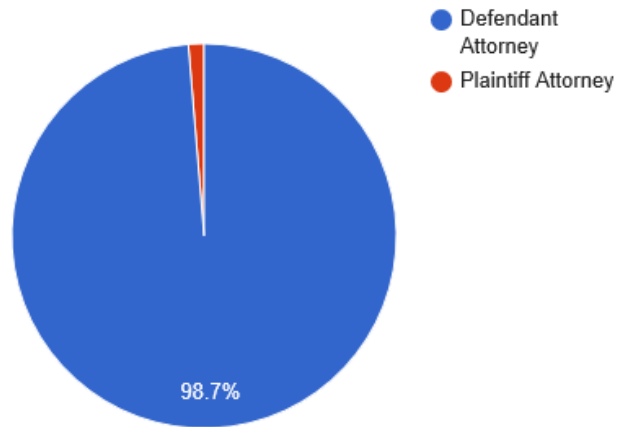

Outcome for Court

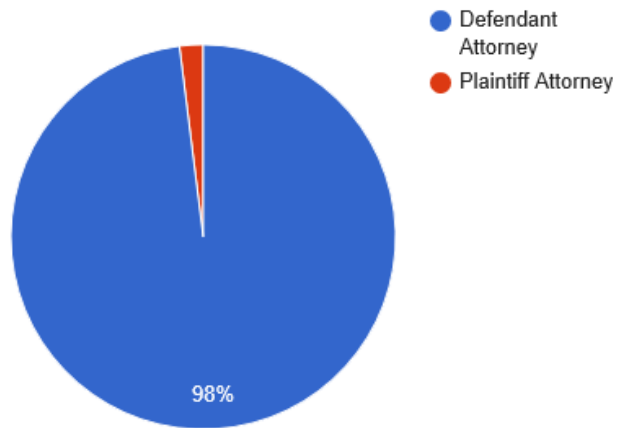


Outcome for Judge Hon. Judge, Domestic Violence

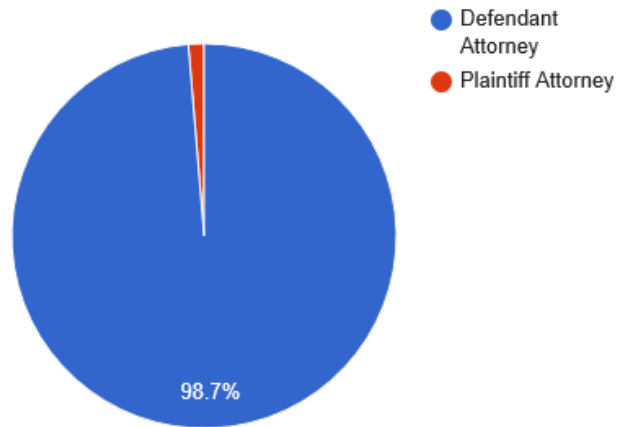

Outcome for Court - Domestic Family Violence

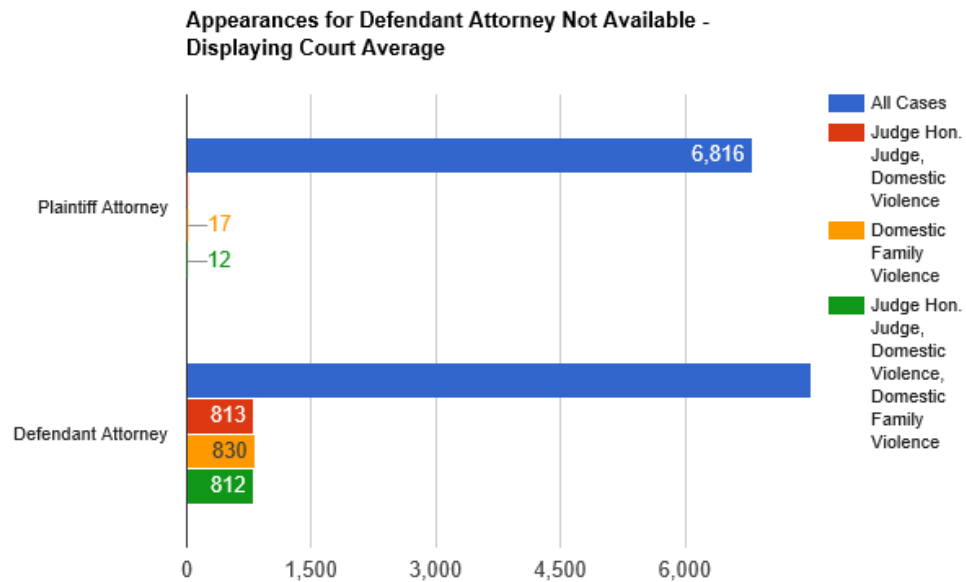
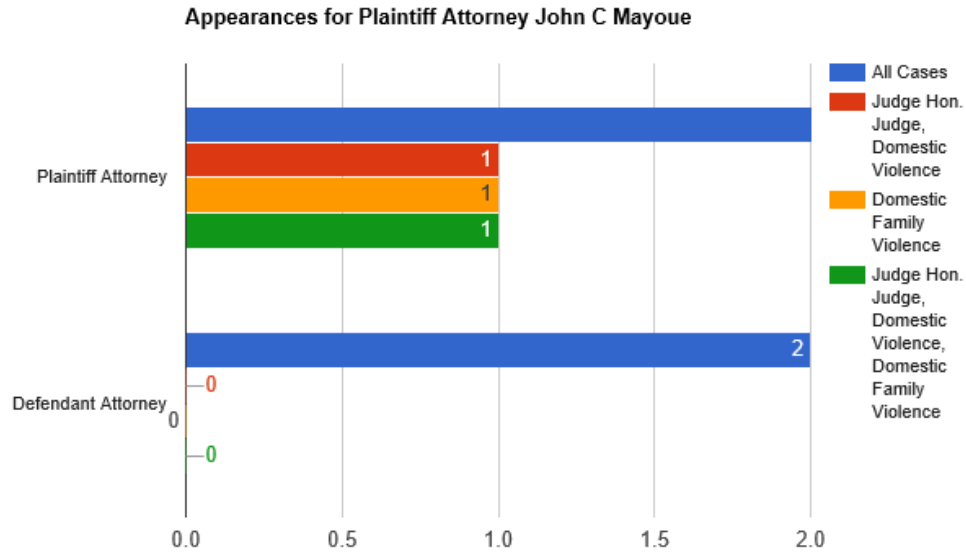


Outcome for Judge Hon. Judge, Domestic Violence - Domestic Family Violence



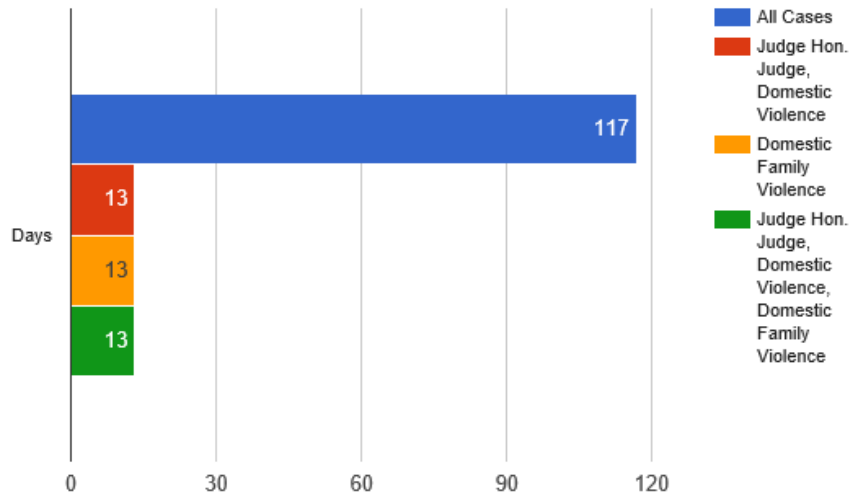

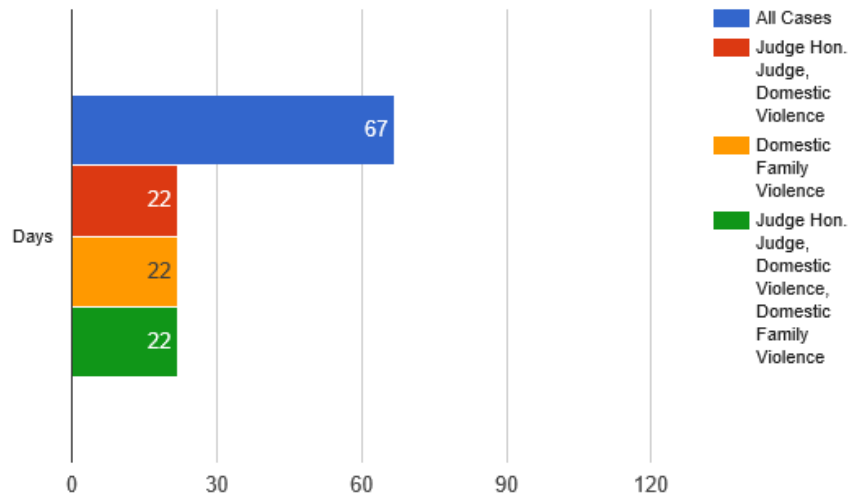

Case Duration for Plaintiff Attorney John C Mayoue

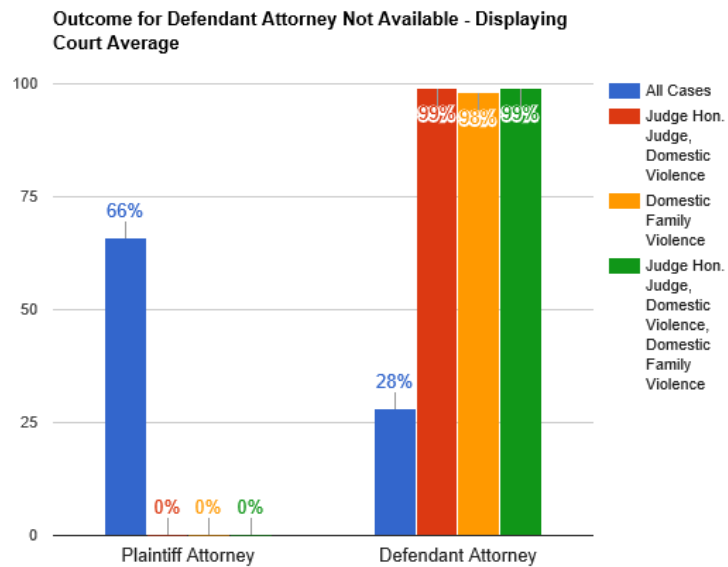
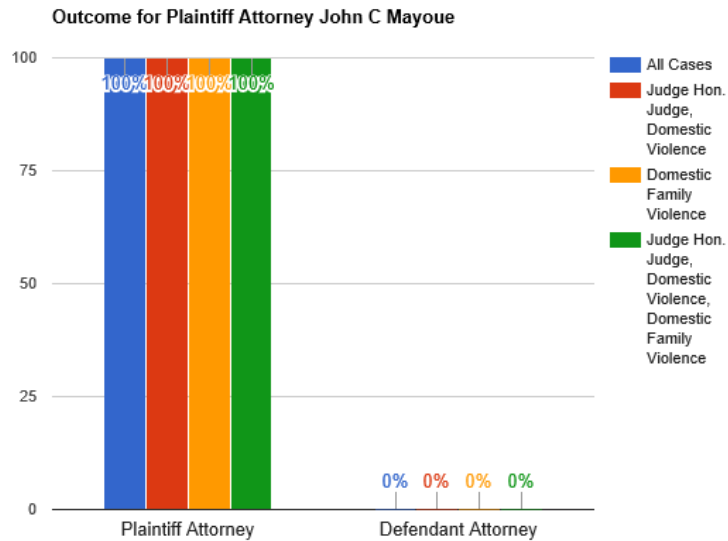


Case Duration for Defendant Attorney Not Available - Displaying Court Average



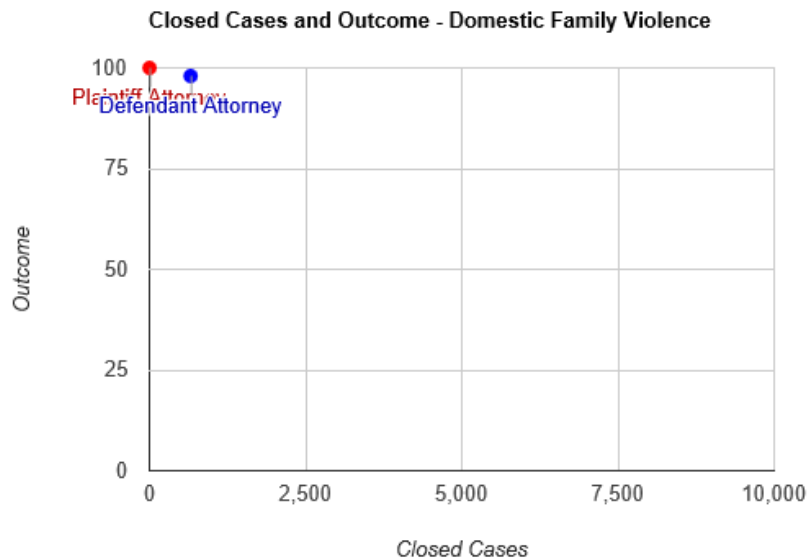
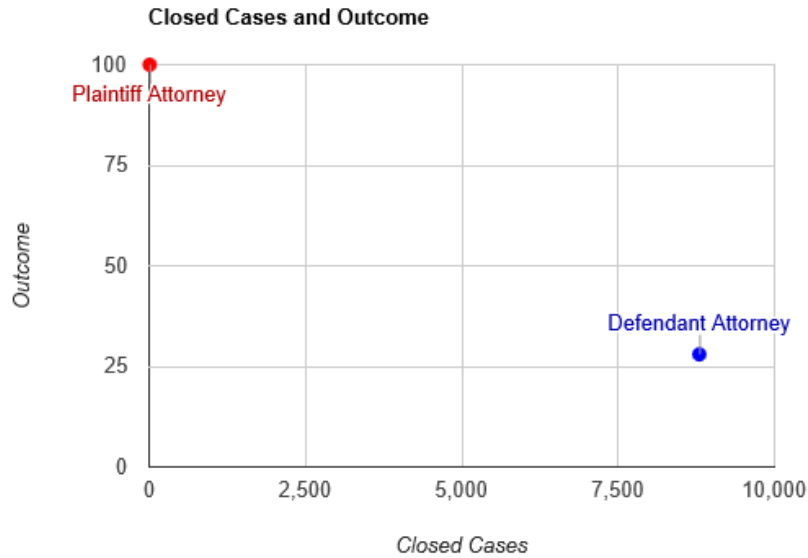
